1. Mirror country

Warmly reminding that as per Canada Customs declaration regulation, the information on Print B/L should match the information that declared to Customs Authorities (CBSA).

Please ensure to provide SI properly. If ACI filling to be submitted by MSC, Manifest (ACI information) and Print B/L should read:

2. Cargo description rows

The total number of cargo description rows shall not exceed 120 per bill of lading. If failing to do this, it will result in an incorrect declaration at the part of destination, and you will be liable for any consequence that accurred

in an incorrect declaration at the port of destination, and you will be liable for any consequence that occurred.

3. Short description

It is mandatory and extremely important for Short description and Long Description to read the exact same commodity. If short Description is only reading the HS code commodity a fine will be imposed by CBSA on POD which will be passed on to your account.

Hence, if multiple cargoes involved, suggest break down with different digits to keep Short description and Long Description reading the exact same commodity.

4. HS code

Require valid Customer HS code(6 digits).
