Dear customers,

Please be informed that effective immediately, as per the notification from our headquarter, it is strictly prohibited to use any of the attached **stop words** in the **short description** of the cargo in both **booking (SO) and shipping instruction (SI)** **by all Trades**. Additionally, the short description must be consistent with the core description of the cargo.

请注意：根据总部通知，**即日起**，对于我司承接的**全航线货物**，严禁在**订舱 (SO) 和提单补料 (SI)** 中的**短货描栏单独使用**附件中的禁用词汇作为货物品名的表述。且短货描栏与货物描述栏中核心品名的描述需保持一致。

We kindly request all agents to adhere to the above requirements when submitting booking information, shipping instruction, and conducting EU ICS2 declarations online (including third-party platforms and myMSC.com). It is essential to provide necessary guidance and explanations to your clients to ensure the accuracy and timeliness of customs manifest transmission and EU ICS2 declarations.

From the date of this notice, we will not notify the list of updates one by one. Please take the initiative to visit the following official website regularly to check the latest version of the information and submit the SI according to the EU customs requirements. We will follow up your SI request directly and any incorrect data will cause extra cost or responsibility, which is on customers' liability. We will not verify with customer at SI stage.
